

3.2 Basis of preparation

The below table describes the basis of preparation for the CSS in section 2;

	Basis of Preparation
Revenue from sale of electricity and gas	'Revenue from sale of electricity and gas' includes electricity and gas sales for the respective retail supply segments.
Other revenues	'Other Revenue' includes grant income under the EBRS and EBDS schemes.
Direct fuel costs	'Direct fuel costs' for supply includes aggregate electricity and gas costs including wholesale energy cost, losses, the energy element of Reconciliation by Difference (RBD) costs, balancing and shaping costs.
Transportation costs	'Transportation costs' for supply includes electricity transmission costs, electricity distribution costs and gas transportation costs.
Environmental and social obligations costs	'Environmental and social obligations costs' includes scheme costs (Feed-in Tariffs, Contract for Difference Feed-in Tariffs, Renewables Obligation, Capacity Market) and the costs of renewable energy certificates (REGO, RGGO, ROCs).
Other direct costs	'Other direct costs' for supply includes Balancing Services use of System charges (BSUOS), licence costs (Elexon charges) and contract acquisition costs.
Indirect costs	'Indirect costs' for supply includes operating expenditure and the costs of bad debt and associated provisions.
Volume	'Volume' is the volume of electricity, measured in TWh, and gas, measured in millions of therms recorded at the meterpoint.
WACO E/G	'WACO' is quantified as [Direct fuel costs] / [Volume]
Meter Points	'Meter Points' means the average number of electricity and gas meter points during the year.

3.3 Hedging Policy

The ENGIE Supply Holding UK Limited group operates a strict back-to-back hedging policy to minimise exposure to market risk, as required by the ENGIE Group mandate. The volume risk is primarily borne by ENGIE Power Limited and ENGIE Gas Limited directly within this mandate.
